### The New Evacuation Plan

n the upcoming weeks, employees at the 15th Street, Akridge, and Lennox Buildings will participate in a drill that will be a test of The Post's new evacuation procedures. Bells will ring and an announcement over the public address system will direct staff to evacuate the three buildings. Dozens of staff assigned

as emergency coordinators will be wearing fluorescent green vests and with the assistance of megaphones will have the responsibility of shepherding hundreds of Post employees throughout the three buildings to assigned evacuation locations as quickly as possible. A night-side drill will also be scheduled in the near future.

Plans for a new evacuation plan were already underway prior to the terrorist attack on September 11. However, the events of that day underscored the need for The Post to have an updated full-scale employee evacuation plan if there is another catastrophic emergency, or in the event of a bomb threat or fire.

Director of Operating Services, **GEORGE WATHEN**, and Administrative Services Manager,

RICK FLOYD, have had the responsibility of developing the plan to ensure the safety of Post employees.

"It is very important that all employees take this drill very seriously," Wathen emphasized. "We need people to follow the lead of their emergency coordinator and get to their assigned evacuation location without delay."

Employees should review the following questions and answers provided by Wathen and Floyd to make sure you understand the evacuation procedure.

#### **Q:** Who are the emergency coordinators?

**A:** On page 2 of this issue of ShopTalk you will find a listing of the emergency coordinators that are assigned to your department or section. The Administrative Services Department has had several meet-

ings with the emergency coordinators since late this winter to make sure they understand their leadership role during an evacuation. Your emergency coordinator/s have designated a central meeting place in the department for staff to meet and then evacuate the building via the closest stairway. The list on page 2 also shows your depart-

ment's assigned meeting place around the perimeter of the buildings. Even if you get separated from staff in your department, go to that meeting place immediately.

#### **Q:** What if I'm on a different floor when the alarm rings?

**A:** There are color-coded locator maps throughout each floor that indicate your location and the nearest exit points. In the lower levels of the 15th Street Building where there is construction, red arrows point people in the direction of the closest exit.

## **Q:** What happens after I get to the evacuation location point for my department?

**A:** Stay put. The emergency coordinator will do a head count and determine that everyone they have responsibility for is at the location. If someone is missing, or is having a medical emergency, etc., the emergency coordinators

the way or go to a different location, you may be putting lives at risk.

## **Q:** Why is my department's evacuation location so far from the building?

**A:** To protect employees from falling debris. After the bomb scare in November, we determined that it was not safe for employees to stand right across 15th Street. We determined that employees should be at a minimum of 100 to 300 feet away from the perimeter of the three buildings. That is why, in some cases, the evacuation location point is two blocks away.

# Q: I work in Akridge and the doors to the stairways lock behind you. Should I go over to the 15th Street Building to evacuate?

**A:** No. Employees have access to the ground floor exit via the stairs at all times. Post employees who work in Akridge are strongly encouraged to exit from Akridge and

have two-way radios to alert Security staff. If someone is missing, fire and emergency response personnel will be looking for that person in the building. That is why it is very important for staff to go to their assigned location and stay there. If you stop along do not cross over to the main Post building. This could unnecessarily delay your evacuation.

# **Q:** I am handicapped and will not be able to evacuate by walking down several flights. What should I do?

A: There are five emergency evacuation chairs that are stationed at the top of stairwells in all three buildings. If you are not able to walk down the stairs, your emergency coordinator should assign a "buddy" to you to get you to the closest evacuation chair location. You should wait at the chair location until everyone else has cleared the stairway. A security guard or emergency response personnel will place you in the chair and accompany the chair down to the ground floor. If you think you will need to use the chair, contact your emergency coordinator for more information. The chair has a weight limit of 300 pounds. A demonstration and instructions on the use of the chair can be provided through Administrative Services. The location of these chairs are in stairways located by elevators: L Street stairway, 7th floor (Southeast corner); main elevator stairway, 9th floor; Lennox Building, 7th floor; Lennox Building, 5th floor by Sports, and 12th floor of Akridge Building.

# **Q:** How will we know when it is OK to go back into the building?

**A:** The emergency coordinators will receive an "all clear" on their twoway radio as a signal for employees to return to their building.

# **Q:** What if I left my ID in my purse at my workstation? How do I get back in the building?

**A:** It is a company policy that all employees, contractors and visitors wear a Post ID at all times in the build-

ing. Your ID should be on you and visible. Security will be checking identification as people come back in the building. Wearing your ID enables us to keep the buildings secure and employees safe.

## **Q:** How can I find out what happened if there is an emergency and we are evacuated?

**A:** Call the Security Information Line at x4-7772. The information is updated by Administrative Services with information about what took place and other pertinent information.

### **Q:** How will it be determined if the new evacuation plan is successful?

**A:** We have used the Fire Prevention Division of the D.C. Fire Department as a resource in creating the evacuation plan. They will have personnel on hand to witness and evaluate the drill and provide us with feedback. We will then provide information to the emergency coordinators to share with the staff in their departments or section.


