# News Story Becomes Play

hankar Vedantam, a reporter on the National Desk, began his journey to becoming a playwright while writing a news story about a paternity dispute when he was working at the *Philadelphia Inquirer* in 1999. His first play, *Tom, Dick and Harriet*, co-written with Donald Drake, is premiering at the Brick Playhouse in Philadelphia on April 7–25.

Vedantam's article for the Inquirer was about a divorced subcolored eyes from the father and his ex-wife, and told him that it was possible the child wasn't his. After a DNA test proved he wasn't the father, the man went to court in order to stop his child support payments. However, according to Vedantam, the law in Pennsylvania and in many other states is that if a child is born into a marriage it automatically belongs to both parents—despite DNA.

Vedantam and Drake, his editor

at the time, discussed the story over lunch at a Burmese restaurant and mused about what it means to be a parent and the importance of genes in deciding who should be a parent. It was then that they decided the story would make a great play and began collaborating on writing Tom, Dick and Harriet.

"The play bears no factual resemblance to the story at all," noted

Vedantam. "The fundamental themes of the play are the same as the story in what does it mean to be a parent. How important are genes in deciding who should be the appropriate parent to a child?"

Tom, Dick and Harriet became a comedy about two men who both wanted to be the "real" father of a child. It is described in a press release by the Brick Playhouse as "a crackling comedy about politics, parents and the press."

"The thing we wrestled with while writing the play is that we didn't want to have a character who was trying to get out of being a father," he explained. "We wanted to explore the issue, but find characters that actually would be sympathetic and that the audience could sort of say 'I can see how the character could feel this way and I might feel the same in this situation.' "

Vedantam and Drake's comedy won a playwriting competition sponsored by the Playwrights Center of San Francisco in 2002. A revised version was accepted for a showcase at the Lark Theater in New York City in 2003. The next version won a national competition last year and received the 2<sup>nd</sup> annual Brick Playhouse Award for Outstanding Writing, enabling them to produce the play.
